# Terms & Conditions

**BOOKINGS:** To secure a date, a signed contract and \$100 deposit are required. This deposit is non-refundable and non-transferable. This deposit will be put toward the guest's total wedding day balance if the guest chooses wedding day services. Please note that bridal consultations and deposit fees are two separate costs.

**TRIAL / CONSULTATIONS:** Consultations are available for brides as well as their bridal party members, including but not limited to: bridesmaids, mothers of the bride and groom, grandmothers, extended family members, guest speakers, etc. Trial consultations are a separate cost from wedding day services.

**LIABILITY:** All brushes, tools, hair and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the guest to the makeup artist or hair stylist prior to application and, if need be, a sample test may be performed on the skin.

**SATISFACTION GUARANTEED:** Makeup and hair styling will be completed to the guest's satisfaction, and acceptance of the completed services are acknowledgement by the guest that the makeup and hair styling is done to the guest's satisfaction.

**PARKING FEES:** Where parking, valet or toll fees may be incurred. This amount will be due on the day of the event. Payment is available on Venmo @SDCMidRivers or @SDCWestClay.

**TRAVEL FEES:** On location services require a \$100 travel fee per stylist. The average wedding party requires 2 stylists. On location for Sundays or Holidays is an additional \$200 fee in addition to the travel fee.

**PAYMENT:** The final balance is due one week before the wedding day. Our Bridal Team will have invoice amounts for each person in the party. The invoice amounts will include a 20% gratuity on the individual total, Additional services may be added (if time permits) on the wedding day. There will be a Venmo option to make those payments @SDCMidRivers or @SDCWestClay. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this contract.

**SOCIAL MEDIA & WEBSITE:** Photos taken at the trial or your professional photos may be used as examples of our work for future guests to view. Your photographer will receive proper credit for their work. You agree to us using these photos, as well as give consent to using your professional photos on our website/portfolio/social media. We will email you to request these photos and photographer information.



# Terms & Conditions...

**SERVICE LOCATION & REQUIREMENTS:** The location of makeup and hair styling services for the day-of-event will be at the Bride's discretion, but there are certain requirements the artist will need to complete the services. A set-up table/work area/chair/trashcan/outlet will need to be made available for the Hair Stylist and Makeup Artist. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. Artist will arrive 15 minutes prior to set-up. Please communicate the hotel room number if applicable by email or text.

**CANCELLATION POLICY:** Your booking is a reserved spot. There is a 50% charge for services cancelled 30 days prior to the wedding day and your deposit is not refunded. All cancellations must be communicated in written form either by email or text.
